SPECIFIC DESCRIPTION OF SERVICES TO BE PERFORMED BY THE CREDIT REPAIR SHOP, INC.

(CRA's - Credit Reporting Agencies)

1. We will help you obtain all of your credit reports from the 3 major reporting agencies (Experian, Equifax and Transunion) if necessary.
2. We will do a complete Audit of your credit reports with you either by phone or in person to determine inaccurate, outdated and/or unverifiable information contained on your credit reports.
3. We will prepare the appropriate documentation to submit to CRA's to initiate a disputes of inaccurate, outdated and unverifiable items appearing on your credit report.
